A majority of the fleet was inspected, and the vehicles look to be maintained in reasonable to good condition for their ages and types. These vehicles essentially being ready to go straight to work could be beneficial today, as new vehicles can take several months to be made ready for work, and quality equivalent ready to work used vehicles can prove difficult to find available for sale. Particularly specialist vehicles such as these examples. However, demand in the used market has significantly reduced in recent weeks, which could influence used vehicle saleability today.
